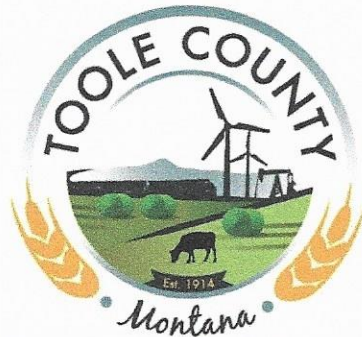

PLEDGE OF ALLEGIANCE

Approval of January 5, 2023, Meeting Minutes: Terry Kimmet motioned to approve, Terry Tomsheck seconded the motion, motion carried.

1. Consider approval of appointing Erin Fenger to replace Chris Vermulm to represent Pondera County on the fair board with a term ending on 12/31/2025. **Terry Tomsheck motioned to approve, Terry Kimmet seconded the motion, motion carried.**
2. Consider appointing Miranda Dupree to replace Linnet Doane to represent Toole County on the fair board with a term expiring on 12/31/2023. **Terry Tomsheck motioned to approve, Terry Kimmet seconded the motion, motion carried.**
3. Consider appointing Lena Tronson to replace Linda Fretheim to represent Toole County on the fair board with a term ending 12/31/2025. **Terry Tomsheck motioned to approve, Terry Kimmet seconded the motion, motion carried.**
4. Consider re-appointment of Janet Hawks to the fair board for a term ending 12/31/2025. **Terry Tomsheck motioned to approve, Terry Kimmet seconded the motion, motion carried.**

5. Consider disengaging the “Step Increase Program” with the Sheriff’s Department beginning January 1, 2023. This would be for any new deputies and the deputies already in this program would be “grandfathered in”. Tyler Foss spoke about the meeting the Sheriff’s Office had on this agenda item. Some employees had concern about losing applicants if this small incentive wasn’t in place.
