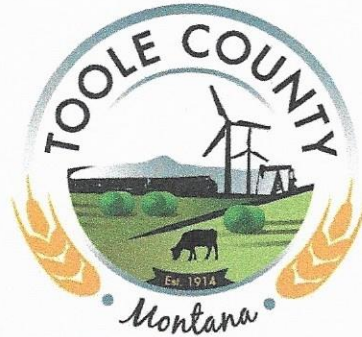

1. Consider entering into a contract with CSN (Rick Ruiz) for a new control system to switch from Johnson Control for the Courthouse, Library, and Sheriff's Office. **Terry Kimmet motioned to approve. Terry Tomscheck seconded the motion, motion carried.**
2. Discussion and possibly approving Stahly Engineers suggestion of doing a survey, geo-tech work, and obtaining a waiver from RPA for the airport elevation for the proposed road shop building at the airport. The cost would be approximately \$15,500 for the Geo-Technical work, \$10,000 for the survey, and \$2,000 for RPA. **Terry Kimmet motioned to approve. Terry Tomscheck seconded the motion, motion carried.** The expenses will be taken out of Fund 4050.

CIVIL FEES SCHEDULE

- 1) Service fees for summons & complaint, subpoena, letters, & postings:
Fee \$75.00 per service/per defendant/per location
 - a. Fee includes only service, mileage, copies & return mailing)
- 2) Service fees of a subpoena
Fee \$75.00 per subpoena/per service /per defendant/per location
 - a. Fee includes only service, mileage, copies & return mailing
- 3) Service fee of Orders, letters etc.
Fee \$75.00 per service/per defendant/per location
 - a. Fee includes only service, mileage, copies & return mailing
- 4) Postings
Fee \$75.00 – Each location
 - a. Fee includes only posting, mileage, copies & return mailing
- 5) Writ of Execution Fees (Only for Wage Garnishments and Bank Levy's)
Fee \$100.00
 - a. Bank Levy's will only be served one (1) time
- 6) Writ/Sheriff's Sale of Personal Property
Fee \$150.00 per Execution
 - a. Fee only includes service, mileage and copies.
 - b. Additional charges will be the responsibility of the Plaintiff and/or Plaintiff's attorney or representative; i.e. advertising, certified mailings, filing fees & etc.
 - c. If personal property is to be seized and stored, the Plaintiff will be responsible for making arrangements for payment of professional towing, hauling and storage of property until sold.
- 7) Writ/Sheriff's Sale of Real Property
Fee of \$250.00 per lot/parcel
 - a. If more than 1 lot/parcel is being sold, additional charge of \$50.00 per additional lot/parcel.
 - b. Fee only includes service, mileage & copies).
 - c. All other charges (i.e. advertising, certified mailings, filing fees etc.) and paperwork will be the responsibility of the Plaintiff and/or Plaintiff's attorney or representative.
